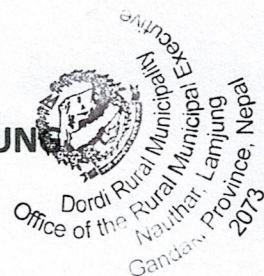

Bids must be valid for a period of 90 (Ninety) days after bid opening and must be accompanied by a bid security amounting to the minimum of as mentioned below which shall be valid for 30 days beyond the validity period of the bid.
