The bids will be opened in the presence of Bidders' representatives who choose to attend at 13:00 noon on 12<sup>th</sup> Magh 2078 (26<sup>th</sup> January 2022) at the office of Dordi Rural Municipality. Bids must be valid for a period of 45 days after bid opening and must be accompanied by a bid security amounting to a minimum of Nrs. 40,000 which shall be valid for 30 days beyond the validity period of the bid.
