- 6. The bid document will be opened in the presence of Bidder's representatives but not mandatory who choose to attend at 1:00 pm on 2077/12/02 at the Dordi Rural Municipality. Bids must be valid for a period of 90 (Ninety) days after bid opening and must be accompanied by a bid security amounting to the minimum of as mentioned below which shall be valid for 30 days beyond the validity period of the bid.
